BASIC INFORMATION

We present you with a new and innovative floor system. The triangular structure of the Mosolut Primastik pavement. This tile can be installed on new and old substrates of varying quality, quickly and easily. The triangular design makes it possible to create a wide spectrum of imaginative patterns, directional arrow formation, or zone marking. Thanks to 100% recyclable material of the highest quality, our design tiles feature high wear resistance, slip-resistant surfaces, long-term stability, and uncomplicated care and maintenance. That's why we guarantee you up to 20 years.

They are suitable for creating a comfortable and safe surface on the home terrace, in the pergola, in commercial spaces, in restaurants, but also in a race depot, or showroom. You also need not worry about using Mosolut Prismatic in very warm environments and wet areas.



WARRANTY

SCOPE OF THE WARRANTY

This warranty applies for Prismatic ranges for indoor and outdoor floor installation for domestic or commercial use only.

PERIOD OF VALIDITY

Mosolut s.r.o. warrants for a period up to 20 years. The warranty begins from the date of purchase of the floor covering by the customer, stipulated on an invoice, mentioning clearly the reference of the concerned flooring product.

TERMS OF VALIDITY:

Only First grade products are covered for following issues:

- Visible defects reported to Mosolut s.r.o. or the retailer prior to laying them such as appearance defects, structural defects, indelible stains.
- Manufacturing defects reported to Mosolut s.r.o. or the retailer during the period of warranty generating premature wear.

This warranty shall be valid provided that all the conditions here in after mentioned have been respected:

- The installation of the product shall be made according to the state of art and in accordance with the updated Prismatic laying instructions applicable to the chosen product.
- The materials are to be maintained in accordance with Prismatic cleaning instructions.
- The specified tiles must be suitable for the use intended, in accordance with recommended use specified for Prismatic

SPECIFIC EXCLUSIONS

The warranty does not apply to the following:

- Products sold in a quality other than first choice,
- The exact matching of shade colour or mottling,
- Defects caused by failure to install in accordance with the laying instructions or specified by Prismatic,
- Mishandled products or products submitted to a use other than domestic, residential or industrial, or unsuitably stored,
- Labour costs for installation of original or replacement material,
- Products damaged during transportation outside Mosolut s.r.o. responsibility or in any other way outside Mosolut s.r.o. responsibility,

- Installation with adhesive other than those recommended by Mosolut s.r.o. if applicable,
- Products with visible defects that were cut or installed nonetheless,
- Products having been improperly maintained, in a way not complying with the maintenance instructions and specifications made by Mosolut s.r.o.,
- Products whose deterioration, leading to their replacement, is due to their laying on an uneven subfloor,
- Variation in color, gloss and embossing structure between the products sold and pictures or samples and, in case of purchasing contracts, variation in manufacturing, including color change between different production batches,
- Damages caused by stains, burns, cuts, grooves, friction, accidental indentations, painted surfaces, yellowing due to an external product (asphalt, tar,...),
- Fading or damages caused by outside sources, including water leaks, flooding, heat and very strong sunlight,
- Coloring caused by tires, feet of waxed pieces of furniture or any other item likely to leave indelible marks.
- Prismatic shall not be liable for any incidental or consequential damages which may result from a defect.

CONDITIONS OF CLAIMS:

Mosolut s.r.o. and the retailer shall be informed by the customer of the defect in writing with a registered letter with acknowledgement of receipt immediately after observation of the defect and no more than 30 days after the claimed defect is discovered.

The defect shall be acknowledged after examination of the floor covering by a Mosolut s.r.o. representative or a duly qualified authorized agent. Mosolut s.r.o. reserves its right to require a sampling with the defect observed in order to analyze it its laboratories.

TERMS OF COMPENSATION

The compensation covers the purchase price of the tiles but excludes the removal costs, the installation dismantling cost (partitions, furniture...) the cost of laying and tools accessories used for laying (glue, skirting boards...). The compensation shall be digressive relative to the elapsed time of the warranty period, taking into account the depreciation of the product:

≤1 year 90%	≤2 years 75%	≤3 years 50%
≤5 years 30%	≤ 10 years 10%	≤ 20 years 5%

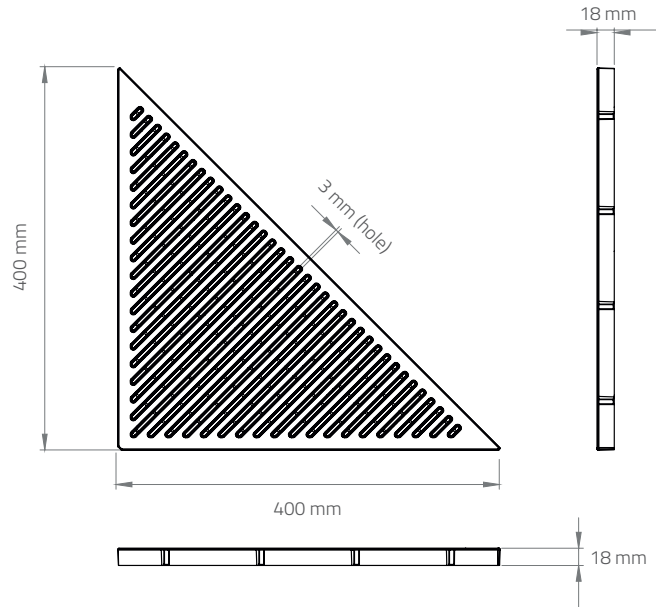
